A. Administrator's Report – Highlights of Current Information

1. Behavioral Health Update

Trina Frazier, Chief Student Services Officer, stated the Charter Schools have access to the downtown Behavioral Health hub and have been assigned one clinician. Trina mentioned an on boarding meeting will be required for Charter staff before clinicians begin providing services.

2. Bill Updates

Trina reviewed current bills that have been passed. Trina stated that AB-2657 passed and went into effect on January 1, 2019. It will change the way restraints and seclusions are used for students. Bill AB-2022 was passed and will go into effect 2019-2020 school year. This bill requires school districts to notify parents no less than twice during the school year on how to initiate access to available mental health services.

3. Governor's Budget Summary – 2019-20

Trina shared the Governor's budget summary and three proposals will need to be approved which are collaboration with general education, transparency around local planning and improving transitions.
