A. Administrator's Report – Highlights of Current Information

1. Legislative Update & Fiscal Update

Trina Frazier, SELPA Administrator informed the members that they will be receiving 100% of the AB130 grant which is now called, Dispute and Resolution. Trina provided clarification on how matching funds is being defined. Trina mentioned that we would match the revenue to the expenditures and the members will have until June 2023 to fully expend their allocation. Trina also mentioned the Learning Recovery funds cannot be used for attorney fees. Trina updated the members on a few bills. The Governor signed bill AB167 which allows for some apportionment for quarantined students. The bill addresses J13A Emergency Process, which is the wavier process to claim for school emergency closures. The Governor also signed bill SB639, The Durazo Bill, which ensures workers with disabilities to earn minimum wage. WestEd was the county office to come up with a new IEP template. New template
