A. Administrator's Report – Highlights of Current Information

1. Legislative Update

Trina Frazier, SELPA Administrator, mentioned that February 18, 2022 was the last day for bill submission and there were many new bills introduced than anticipated. Trina reviewed a few bills that are currently being watched. Trina discussed the neutral stance on SB237 the Portantino bill regarding Special Education and dyslexia risk screening. Bill SB1397 is extending the number of days you can have a substitute in a classroom to 60 days. We are asking for an amendment for Special Education to go from 40 days to 60 days to coincide with general education substitutes. Trina will provide an update at the next meeting.

2. Fiscal Update

There were no fiscal updates regarding the Governor's proposal. Trina shared that we are waiting for the May revise for more information.
