#### 1. Legislative Update

#### 2. Fiscal Update

Romy shared that the Governor released his proposed 2023-24 budget which includes three programmatic changes. First, limiting amount of additional funding that SELPAs are allowed to retain for non-direct student services, stabilizing current SELPA memberships by postponing new single-district SELPAs by two years, and third increasing transparency and making sure that CDE is posting the SELPAs Local Plan on their website.
