A. Administrator's Report – Highlights of Current Information

*Legislative Update

Romy Chachere SELPA Director reviewed the legislative calendar. The Governor's 2025 budget will be released by January 10, 2025 and the last day for bills to be introduced is February 21, 2025. Romy shared bill AB-2173 (Addis) Emotional Disability has been chaptered. SB-445 (Portantino) was signed by the Governor. CDE will be responsible for developing the IEP template and translating it into the ten most common languages. SB-483 (Cortese) will take effect on January 1, 2025. AB-438 (Blanca Rubio) this bill was signed by the Governor and will take effect on January 1, 2025.

Fiscal Update

Romy mentioned that we are waiting for the Governor's budget proposal that is scheduled to be announced on January 10, 2025.
